RESOLVED, upon the recommendation of the Superintendent, the Chester Township Board of Education, in the County of Morris, New Jersey, approves the following resolution in accordance with N.J.A.C. 6A:9-6.5c:

WHEREAS, an adequate pool of substitute teachers and coaches would be available to the district by allowing county substitute candidates to receive the substitute credential pending receipt of the criminal history qualification letter, consistent with other certifications.

WHEREAS, present code requires that all candidates for a county substitute credential have an approval letter from the CHRU (Criminal History Review Unit).

WHEREAS, use of the emergent hiring process by county substitute credential applicants would extend to them the same process available to all other candidates for employment that are awaiting the completion of the criminal history records check.

AND WHEREAS, the proposed waiver would be discussed at the regularly scheduled public meeting of the Board of Education.

THEREFORE, BE IT RESOLVED, based on the recommendation of the Superintendent, that the Board of Education approve the submission of an Application for Waiver for Substitute Teachers and Coaches.
